**1 - 3:00    TN Nuclear Waste Dump Panel:** The nuclear industry and the Department of Energy are using Tennessee as an unlicensed nuclear waste dump. A panel will describe the import of nuclear waste into Tennessee from across the nation and world; how nuclear waste is getting into our county and city landfills; what Nuclear Fuel Services is doing in Jonesborough, TN; and how Memphis continues to be a watchdog for low-income communities living near two companies that process so-called low-level nuclear waste, as well as their victory in stopping a nuclear waste incinerator from coming to downtown Memphis. **Panelists include** Diane D'Arrigo (Nuclear Information & Resource Service, Washington, DC), Linda Modica (Erwin Citizens Awareness Network), and Rita Harris (Memphis Sierra Club Environmental Justice Program.)
